Leah agrees to perform the following services and in accord with the following terms and conditions. On the day before the event, Leah will arrive to set up her table and check accomodations for at least 60 minutes. On the day of the event, she will arrive at least 60 minutes before the Made Matchless Experience presentation begins to pray, ask additional questions, and greet guests. During the event, Leah will lead a mixture of teaching sessions, activites, and craft sessions based on "9 'I Am' Statements Every Girl and Woman Needs to Know" for the duration of 6 hours. She will get three 15-minute breaks during that time. She will eat lunch with the guests. Leah will give a short presentation of her Made Matchless curriculum to the moms near the end of the Made Matchless Experience. Leah will stay up to 60 minutes after the presentation to talk with people at her resource table (table time) and sell her resources. She will stay after for about 30 minutes to pack up her resources. Her schedule will follow the event schedule agenda.

Leah's speaker fee shall be in the amount of \$1,000.00. She will also receive compensation for travel and expenses, contingent upon the completion of the presentation as detailed above. Reasonable travel shall be of a public carrier per Leah's choice. A \$500 deposit is required for setting the event date stated above through this contract. The deposit will only be refunded for adverse weather conditions or if Leah is too ill to present. (Church name) has agreed to cover the airplane travel and accomodations from (accommodation dates). (Church name) agrees to pay Leah by Certified Check that is made payable to Leah Tatina at the conclusion of the presentation. Once Leah's contract duties are complete, (Church name) will provide the certified check for the remaining \$500 plus any travel and accommodation expenses not already paid for by (church name).

Leah shall present, as described herein as an independent contractor, and Leah shall have no obligation with regard to such presentation, as a result of this Agreement to anyone other than (church name).

Leah shall conduct at least one 30-minute interview with print or electronic media at least two weeks prior to the presentation for purposes of publicizing the presentation. Interview details will be directed by (church name) and in conjunction with Leah.

Leah shall publicize the event on her website under www.madematchless.com/events, set up a landing webpage for the event, set up an emailing list, and will contact those on the email list prior to and after the Made Matchless Experience. She will share information about the event on her social media accounts through posts, videos, and live videos. Leah will also donate one of her resources as a giveaway during the event.

(Church name) shall establish the cost of registration, take payments from attendees, be responsible for attendee registration, and will create a working registration link to be shared. (Church name) shall be responsible for any advertising for the event at their facilities and facilities/schools/organizations in the surrounding area. (Church name) shall be responsible for sharing the event in appropriate social media accounts and shall be responsible for setting up a Facebook event as a means of inviting people to register.

(Church name) shall be responsible for the purchase of craft materials required for portions of the presentation as well as any printed or take-home materials for attendees. Specific craft materials, stated in the host packet, will be used to maintain quality consistency across events.

(Church name) shall furnish facilities for the presentation at its own expense and such facilities shall be of good condition with adequate lighting, heat, air conditioning, podium, visual equipment (such as a presentation projector and screen) and sound equipment. (Church name) shall provide a photographer (amateur or professional) from 8:00 a.m. to 9:30 a.m. on the day of the event, in addition to any other publicity photographs they'd like to take.

(Church name) shall provide Leah a suitable area near the presentation for Leah to display and sell educational materials that are produced by Leah.

Leah agrees that she will not conduct any community style presentation or lecture within a twenty mile radius of (Church name) presentation for a period of two months before the presentation on the topic chosen. It shall also be agreed upon that any scheduled violation of this paragraph shall be conclusive evidence of irreparable damage to (Church name) and that (Church name) has a right to prevent such a community presentation to remedy the breach of contract. If it is discovered after the fact that a breach has occurred (Church name) has a right to immediately cancel this Speaker Agreement and Leah shall be responsible for all damages incurred by (Church name) up to the time of contract termination.

If Leah does not appear or perform to the terms of this Agreement, then Leah shall be responsible for the payment of all damages, costs and expenses that were brought upon (Church name) due to her not showing for the presentation. Also, (Church name) shall not be

responsible for any payment if Leah fails to give the presentation due to conditions that are beyond the control of Leah, for example medical disability and or an act of God that is outside of Leah's control.

(Church name) has the right to simulcast or to produce a delayed broadcast of Leah's presentation through a closed circuit or public television / radio or commercial cable television. This license shall be non-exclusive and the copyright of such license shall belong to Leah. If (Church name) does record Leah's presentation a copy of the recording shall be given to Leah approximately thirty days following the presentation.

Copies of the recording of Leah's presentation may be maintained by (Church name) for the sole use of its employees. Leah grants (Church name) to maintain copies of the presentation and for them to use such copies for internal viewing purposes only.

No other audio taping or videotaping of Leah's presentation shall be permitted without prior authorization by Leah.
