Leah agrees to perform the following services and in accord with the following terms and conditions. Leah will arrive at least 45 minutes before the presentation begins. Leah will give one 50-minute sessions about the topic of (<u>Title of presentation topic</u>) with approximately 10 minutes for Q&A. Leah will stay up to 45 minutes after to talk with people at her resource table (table time).

Compensation shall be in the amount of \$200 plus travel and expenses and will be contingent upon the completion of the presentation listed below. Reasonable travel shall be of a public carrier per Leah's choice. (<u>The group/business</u>) agrees to pay the speaker by Certified Check that is made payable to Leah Tatina at the conclusion of the presentation.

Leah shall present, as described herein as an independent contractor, and Leah shall have no obligation with regard to such presentation, as a result of this Agreement to anyone other than the (<u>The group/business</u>).

Leah shall conduct at least one 15-minute interview with print or electronic media at least two weeks prior to the presentation for purposes of publicizing the presentation. Interview details will be directed by (<u>The group/business</u>) and in conjunction with Leah.

(<u>The group/business</u>) shall furnish facilities for the presentation at its own expense and such facilities shall be of good condition with adequate lighting, heat, air conditioning, podium, and sound equipment (when sound equipment is necessary). (<u>The group/business</u>) will also be responsible for providing any necessary printed learning materials (such as handouts) that are created by Leah.

The above mentioned speaker agrees that she will not conduct any community style presentation or lecture within a twenty mile radius of (<u>The group/business</u>)'s presentation for a period of two months before the presentation for (<u>The group/business</u>) (with the exception of <u>one private, weekly class already scheduled</u>) on the topic chosen. It shall also be agreed upon that any scheduled violation of this paragraph shall be conclusive evidence of irreparable

damage to (<u>The group/business</u>) and that (<u>The group/business</u>) has a right to prevent such a community presentation to remedy the breach of contract. If it is discovered after the fact that a breach has occurred (<u>The group/business</u>) has a right to immediately cancel this Speaker Agreement and Leah shall be responsible for all damages incurred by (<u>The group/business</u>) up to the time of contract termination.

If Leah does not appear or perform to the terms of this Agreement, then Leah shall be responsible for the payment of all damages, costs and expenses that were brought upon (<u>The group/business</u>) due to her not showing up for the presentation. Also, (<u>The group/business</u>) shall not be responsible for any payment if Leah fails to give the presentation due to conditions that are beyond the control of Leah, for example medical disability and or an act of God that is outside of Leah's control.

(<u>The group/business</u>) has the right to simulcast or to produce a delayed broadcast of Leah's presentation through a closed circuit or public television / radio or commercial cable television. This license shall be non-exclusive and the copyright of such license shall belong to Leah. If (<u>The group/business</u>) does record Leah's presentation a copy of the recording shall be given to Leah approximately thirty days following the presentation.

Copies of the recording of Leah's presentation may be maintained by (<u>The group/business</u>) for the sole use of its employees. Leah grants (<u>The group/business</u>) to maintain copies of the presentation and for them to use such copies for internal viewing purposes only.

No other audio taping or videotaping of Leah's presentation shall be permitted without prior authorization by Leah.

(<u>The group/business</u>) shall provide Leah a suitable area near the presentation for Leah to display and sell educational materials that are produced by Leah.

This contract shall be governed by the laws of the State of Illinois in Kane County and any applicable Federal Law.
